It is the only celiac specific research granting program in Canada.

Dear Stakeholder,

Celiac Canada (CCA) is pleased to announce applications for the **2024 Dr. James A. Campbell Research Awards** are now open. Since its inception, the J.A. Campbell

Research Fund has distributed over \$350,000 in grants.

Two grants are available – one main grant for up to \$25,000 and a second for young investigators for up to \$5,000 – offered by the CCA for research projects in Canada of a scientific, applied science, and/or medical nature relevant to celiac disease, dermatitis herpetiformis, and/or non-celiac gluten sensitivity, or the socio-economic implications of delayed diagnosis and/or living with these conditions.

For the next two years, CCA is particularly interested in research that is geared towards investigating vulnerable populations or under-investigated communities related to celiac disease such as individuals who are impoverished, food at risk, newcomers, racialized and/or indigenous communities; however, applications are not limited to this subject area.

Grants in Aid of Research in Celiac Disease, Dermatitis Herpetiformis and/or Gluten Sensitivity in Canada



Award

A grant of up to **\$25,000** is offered by Celiac Canada (CCA) for research projects in Canada of a scientific, applied science, and/or medical nature relevant to celiac disease, dermatitis herpetiformis, and/or non-celiac gluten sensitivity, or the socio-economic implications of delayed diagnosis and/or living with these conditions.

2021 - 2024

CCA has an interest in investigations covering celiac disease and vulnerable and/or under-investigated populations (indigenous, newcomers, impoverished and racialized communities), seniors, and the impact of COVID-19, however, applications are not limited to this subject area.

Purpose

This award is to encourage research and further the understanding of the full range of implications of celiac disease (gluten-induced enteropathy), dermatitis herpetiformis, and/or non-celiac gluten sensitivity.

Application

Applicants must download and complete our application form which can be downloaded at https://www.celiac.ca/healthcare-professionals/research-awards/

Completed applications must be received by Celiac Canada no later than April 30, 2024, and each will be acknowledged. These applications will be forwarded to the Professional Advisory Board of Celiac Canada for adjudication.

Notification

The successful candidate will be formally notified by **June 30, 2024**.

Award

Payment and Reporting for the Award are governed by CCA's 'Payment and Reporting Guidelines'. Generally, grants are payable in two (2) instalments. The first instalment (80% of the award) will be paid upon receipt or notice from the investigator of ethics approval, and that the project is ready to start. The second instalment (20%) will be paid upon receipt of a satisfactory final report.

Publicity and Access

The Award recipient is expected to present the work following its completion either at the next CCA National Conference and/or a special webinar. If there are any expenses to attend or participate in these meetings, they will be covered by Celiac Canada in accordance with CCA's guidelines. Notwithstanding the author's rights to publication, the CCA shall be granted the right to publish the final report, whole or in part, in its publications including electronically.

A grant of up to **\$5,000** is offered by Celiac Canada (CCA) for work done in Canada (or byan investigator from Canada temporarily working elsewhere and committed to return to Canada) of a scientific, applied science, medical and/or social nature relevant to celiac disease (gluten-induced enteropathy), dermatitis herpetiformis, or other gluten related disorders.

2021 - 2024

CCA has an interest in investigations covering celiac disease and vulnerable and/or under-investigated populations (indigenous, newcomers, impoverished and racialized communities), seniors, and the impact of COVID-19, however, applications are not limited to this subject area.

Eligibility

The individual must be a trainee in a recognized Medical or Health Sciences School, University Undergraduate, or Graduate Training Program.

From the mentor/supervisor (2-page limit):

- 1. Assessment of the applicant

From the applicant or mentor/supervisor:

- 1. Project goals, rationale, and paragraph summary of research suitable for the public
- 2. Description of the research including aims, methods, and statement about how the research will advance knowledge. Limit to two pages plus appropriate supportive references.
- 3. Itemized budget for salary, materials, supplies and services (1 page). Travel will not be funded.

If this award is sought in conjunction with the JA Campbell Research Grant, include a statement outlining how the funds for each award will be separately used.

The Professional Advisory Council of Celiac Canada will decide regarding the winner or winners, based on the suitability and quality of the proposed work. The recommendation of the Professional Advisory Council will be forwarded to the Board of Directors of Celiac Canada for ratification.

Notification

The successful candidate will be formally notified by June 30, 2024.

Award

The award is payable in full following the CCA's decision, and upon receipt or notice from the investigator of appropriate ethics approval and that the project is ready to start.

Reporting

The applicant will submit to the CCA an interim or final report at the one-year anniversary date and a final report upon completion of the project.
